Preliminary Steering Discussion (2:00 pm)

- Libdata computer time session glitches at El Centro
 - Time sessions extending on their own without library staff input
 - Temporary passes used again and log back on to the previous session
 - IT will look into each issue brought forward
- IT is applying for grant funds to receive Antivirus programs for both staff and patron computers
- Hotspot issues
 - The new hotspots have been experiencing issues with patrons being unable to access Youtube on them
 - Soon there will be youth and adult hotspots
 - Both will have some filtering
 - Look into using hotspots to access Koha to create new library accounts when doing outreach
 - Seeking out possible additional protections for library laptops in case of theft
 - Unable to access Koha on another filtered internet
 - Possibly due to IP address
 - Hotspots are coming in
 - With varying IP addresses
 - Reaching out to Tech Services to see if applying hotspots tweaked to library employee needs is possible
- Research into Library Freedom Project

Check in on the Libdata time glitches

- Check in on the new grant for the antivirus program
- Cybersecurity updates
 - Email security gateway looked to be procured and launched with grant fundsto make Gmail safer by
 - Encrypting emails
 - Filtering emails
 - Intrusion detection services
 - Extra sensors to survey possible cyber attacks or data extraction through IP address
 - Awaiting approval for the funding on some of the mentioned cybersecurity updates
 - Will be priced out in the upcoming 2026 budget
- Hotspot Access & Filtering
 - There will be a difference between youth and adult hotspots
 - AT&T have great filter which is compliant withChild Internet Protection Act (CIPA)
 - Libraries adhere to CIPA law due to funds received through the FCC
 - Stickers placed on the hotspots will differentiate between adult and youth versions
 - A good balance of filtering and granted access will be provided to ensure compliance with CIPA
 - If hotspots are checked out with an adult card, the filter can be turned off
 - More to come
- IP address on hotspot issues for outreach
 - Guided to instead use the Verizon hotspots for staff which are funded by the library's annual telecommunications budget
 - Citrix DaaS used as security to access off-site library resource like Koha, this is approved access only through the Director's Office and IT
 - Committee members agree it is best to use library assigned materials for outreach
- Policy is being written to match current practices for remote work
- Shoutouts
 - BK attended Pueblo Pride with a library booth and very successful in outreach
 - IT wants to recognize the PCCLD district as a whole in their unwavering support revolving cybersecurity resources
 - LHG saw replacement of older item piece
 - PW branch team for being flexible with moving to a temporary location during the roofing project

- Finance is busier but still successful in finishing up projects
- LU is ahead of schedule in shelving old and new materials for the upcoming grand opening of the branch
- LB successful in new mystery checkout bundles aimed for teens and youth that come with a snack
- ELD new two hour limit in cafe on first floor is very helpful in preventing issues with personal belongings policy
- Sherri Baca gave a huge shoutout to the PW team for being patient and flexible during the roofing project, as well as the other departments who are still hard at work despite short staffing
